
This reconstitution is made in strict compliance with the regulations and guidelines of the All-India Council for Technical Education (AICTE), the directives of Biju Patnaik University of Technology (BPUT) and in pursuance of the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions.

The reconstituted Committees shall function as statutory bodies of the Institute to ensure effective implementation of anti-ragging measures and to maintain continuous vigilance across the campus, hostels, college transport and all other institutional premises.

The primary objective of these Committees is to foster and sustain a safe, secure, disciplined and ragging-free academic environment. The Committees shall proactively prevent incidents of ragging, promptly address complaints, conduct necessary inquiries, and recommend appropriate disciplinary action against individuals found guilty, strictly in accordance with applicable statutory norms.

Anti-Ragging Committee

- a) The duty of the Anti-ragging Committee is to ensure compliance with the provisions of BPUT Regulations on curbing the menace of Ragging, as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-ragging squad in prevention of ragging in the Institution and shall punish a student found guilty as per the regulation of BPUT according to the enquiry report along with recommendations submitted by anti-ragging squad.
- b) The Committee shall prepare posters preferably multi-coloured indicating the provision of law, punishment etc. which will be prominently displayed on all Notice Boards of all departments, hostels and other buildings as well as at vulnerable places.

Anti-Ragging Squad.


- a) The duty of Anti-Ragging Squad is to maintain vigil, and remain mobile, alert and active different vulnerable points (College, Canteen, Corridors, Hostels, Café, Bus-Stop, etc) at all times
- b) It shall be the duty of the Anti-Ragging Squad to make surprise raids to hostels, and other places vulnerable to ragging.
- c) It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incident of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the staff of any student or any parent or guardian or any employee of a service provider and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action as per regulations of BPUT.
- d) The Anti-Ragging Squad shall conduct such enquiry following a fair and transparent procedure and the principles of natural justice giving adequate opportunity to the student or students accused of ragging and to other witnesses.


